# REPORT ON SHORT-TERM VISIT TO WURZBURG UNIVERSITY, GERMANY ERASMUS+ KA 171 PROGRAMME 2023.

#### **Introduction:**

I had the pleasure of attending the Adult Education Academy at Wurzburg University, Germany, which was organized from 6<sup>th</sup> to 17<sup>th</sup> of February 2023. This winter school was focused on the international and comparative study in the field of Adult Education and Lifelong learning. The structure of the Adult Education Academy is divided into an online preparatory phase, a two-week intensive programme(6-17 February) featuring an online work phase from 6-10 February 2023 & an on-campus work phase from 13-17 February 2023 in Würzburg, and an optional follow-up.

#### **Purpose:**

The purpose of the winter school was to provide an opportunity for researchers, professionals, and students to come together and share their knowledge and expertise in the field of Adult Education and Lifelong Learning. The Adult Education Academy promotes international networks in adult education and lifelong learning, aiming to foster a connection between academic learning and the field of adult education.

During the preparatory phase and the two-week intensive programme, participants develop and refine their analytical and comparative skills in adult education in an international environment. They gain an under-standing of internationally relevant educational policies in the context of lifelong learning, while strengthening their communication, teambuilding and critical thinking skills by working together in this international setting.

#### **Activities:**


The Winter School offered various activities, including lectures, presentations, and workshops, which were conducted by some of the leading researchers and experts in the field. The lectures were aimed at providing the participants with an overview of the latest research and developments in the field of Adult Education and Lifelong Learning. The presentations and workshops were more interactive and hands-on, where the participants got a chance to work on real-world problems and learn about the latest tools and techniques used in the field.

#### Further the activities involved:

- 1. Online Mode: Online Preparatory Phase provided participants with the necessary knowledge and abilities for the two-week Adult Education Academy programme in February 2023. It helped me in writing and finalising the transnational essay.
- 2. Two week Intensive Program which further sub-divided into online and onsite on campus part. The first week was online mode and second week was offline mode, that is on campus of Wurzburg.
  - a. 1<sup>st</sup> Week(Online): International strategies in adult education, Classes on educational policies, adult education in Germany, analysis of models. Online Field visit were also organised.
  - b. 2<sup>nd</sup> Week(On-site): Introduction to comparative adult education and comparative group work was done.


I was part of *Comparative Group 9(Adult learning and education for all?! Issues of inclusion in the limelight)*, where the participants belonged from Germany, Hungary, India, Portugal, Nigeria. The discussion mainly focused on the disability and inclusion. The parameter of comparison taken are Policy, Provision and Professionalization. Further the axes of Adult and lifelong learning were also in the intersectional study. My transnational essay also focused in the same context with further intersecting to the caste, disability and their inclusion in Indian context.

#### **Learning Experience:**

#### **Suggestion:**

- Recognition of ECTS (European Credit Transfer System) in our education system. So I would recommend that UGC and Delhi University shall recognise the credit transfer so that the mobility further be increased and students & scholars could grab benefits of the winter school or long term mobility program.
- 2. Grading of Article in European Country to be recognised in our university system.
- 3. Apart from the academic, the institutional support from International Office of Delhi University are required for easy mobility. As sometimes student find difficulty in Visa processing, so it is requested to bring some coordination between the embassies and university for mobility program.

#### **Conclusion:**

Overall, I found the Winter School at Wurzburg University to be a valuable learning experience. The comparative group (CG) discussion in addition to the earlier task like preparatory phase, CG9 topic discussion, Introductory session on Adult and Lifelong Learning and Field Visit were very informative and provided me in-depth knowledge about the same. #### Visit to Adult Education Academy 2023

#### **Introduction:**

The visit was made possible through a MoU between Department of Adult, Continuing Education and Extension, University of Delhi and Julius Maximilian University in Wurzburg, Germany. I am selected for the scholarship provided by ERASMUS, the European Union's education program. The aim of the visit was to gain insights into the adult education system in Germany and to learn about innovative approaches to adult learning. This 15-day visit to the Adult Education Academy in Wurzburg, Germany, was an enriching experience. I am Anuja Virmani, a bonafide final year master's student at the Department of Adult, Continuing Education and Extension, University of Delhi. In 2021, I completed by bachelors in social work and took admission in the department of Adult Education for my master's degree as I found the course as well as the syllabus very unique and interesting. In the initial days only, I got to know about the winter school program and also about the opportunity of my participation in the same. So, I begin my preparation for the selection process and after appearing in the 3 level selection process, I got the first rank among all the participants. I was highly motivated to avail this phenomenal opportunity which was going to provide me an international academic exposure. Also, I was very curious to understand the perception and scenario of adult education in other countries and the type of programs that the countries are undertaking in the name of adult education.

It was a two week program out of which the first week was online and second week was on campus. I received Erasmus+ scholarship for my visit to Julius Maximilians University of Wurzburg, Germany. As a part of choosing our respective comparative groups to work on in the second week, I chose Active Ageing as I found it highly relevant and useful with the Indian demography. There, I had students, scholars and practitioners from Nigeria and Italy in my comparative group and for the one whole week we all discussed about the scenario of active ageing in our respective countries. These were very fruitful discussions for me as I got to know about some very interesting facts about the two countries. For instance, in Italy, the prevalence of paid caregivers for the elderly is very common and those are not professional caregivers but actually those people who do this work freelance for the extra income. Similarly, in Nigeria, there is a 'Death Program' under which people who attain the age of 60-65 are being mentally prepared for their old age and death. Apart from my academic learnings, there was so much more that I learned there such as the impact of classroom setup, the benefit of absence of hierarchy, to mention a few.

I will always remain thankful to the Adult Education Department for providing me with such a big opportunity. I feel myself very grateful to be a part of this department. I will use my learnings to take my career to greater heights by using my professional connections that I made there at the Adult Education Academy for group paper publications and for my participation in the similar international academic programs in the future. As per my experience as a student of social sciences,

I think the master's degree offered by the Department of Adult Education should also inculcate a mandatory field work component in which students can actually work with the adult population and understand their learning styles and behavior dynamics. The department can also work on extension activities as most of the Adult Education departments in India are running various projects under the name of extension activities.
