## **Proctor Office Report**

The Proctor's Office in University of Delhi is an office which work 24x7 throughout the year. The office sees that the University campus is violence-free and ensures discipline and peace among the university students.

The following activities were performed by the Proctor's Office which are mentioned below:

## **Activities**

Holi Committees were constituted on 06.03.2019, 28.02.2020, 19.03.2021, 05.03.2022 & 28.02.2023 and Proctorial Board Meetings were held on 12.03.2019 at 03:00 PM, 26.02.2020 at 03:00 PM, 22.03.2021 at 03:00 PM, 11.03.2022 at 03:00 PM & 01.03.2023 at 03:00 PM with Delhi Police/Principals/Representatives of Colleges, Provosts/Wardens of Hostels and University Officials to discuss about the steps to be taken to curb any Hooliganism in the name of Holi Festival, to ensure the security of the students especially girls students in and near the University Campus and its Colleges. The Control Room was set-up for 07 days by Proctorial Board, DSW Members, and Police Staff for zero tolerance to hooliganism in the name of Holi festival. The Guidelines and Flex Boards/Hoardings in English & Hindi were pasted at different places in the University Campuses and also displayed on the website of the University.

Antiragging Committees were constituted on 16.07.2018, 18.07.2019, 18.11.2021, 21.10.2022 & 09.08.2023 and Anti-Ragging meetings were held on 13.07.2018, 12.07.2019, 18.11.2021, 21.10.2022 & 11.08.2023 at 03.00 p.m. with Delhi Police/Principals/Representatives of Colleges, Provosts/Wardens of Hostels and University Officials to discuss about the steps to be taken to avoid ragging. The Control Rooms were set-up at Proctor's Office for approx. 07 days by Proctorial Board, DSW Members and Police Staff for zero tolerance to ragging. The Flex Boards/Posters/Hoardings



in English & Hindi were pasted at different places in the University Campuses and also displayed on the website of the University. The Antiragging guidelines were sent to all Colleges/Departments/Hostels to curb the menace of ragging and instructions were given to download the UGC and Himmat App. Anti-Ragging weak days also performed by the Proctorial board as per UGC instruction in the University Campus. Various Antiragging complaints were handled.

The Proctor's Office had completed the **elections of three student members to the Internal Complaints Committee (ICC) 2019 & 2022** as per the guidelines in terms to Section 4 (1) (c) of the University Grants Commission (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015.

The Proctor is Co-Chairperson of **Campus Development Committee** which was constituted by the Competent Authority on 05.06.2023, 15.05.2023 and 19.06.2023

The letter was issued by the Proctor's Office to the Lt. Governor, Government of India on 28.03.2023 through Deputy Commissioner (South), Transport Department, Government of Delhi regarding the **Supply of Electric bus service** in the North Campus, University of Delhi.

The Proctor's Office ensured the smooth conducting of **96**<sup>th</sup>, **97**<sup>th</sup>, **98**<sup>th</sup> **& 99**<sup>th</sup> **Annual Convocation** of University of Delhi were held in the Multipurpose Hall, University Stadium.

The Proctor's Office ensured the smooth conducting of **64**<sup>th</sup> & **65**<sup>th</sup> **Annual Flower Show** of University of Delhi were held in the Gautam Buddha Centenary Garden, University of Delhi

The Proctor's Office is collaboration with NCWEB had arranged **Cyber Safety Awareness Campaign/Programmes** in 26 centers of the NCWEB.

**Road Safety Awareness Programme on Phygital Mode** was held on 14.04.2023 around 12:00 noon near the Vivekanand Statue, Arts Faculty, University of Delhi by Ministry of Road Transport and Highways with the help of Proctor's Office.
