may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any ank) directly. UGC has developed a dedicated web portal (https://scholarship.canarabank.in) for capturing data of the wardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal ith unique Maker and Checker IDs which have already been provided to them along with the passwords. The niversities/Institutions shall update the information on the master data (regarding monthly payment confirmation, RA, up-gradation, resignation etc.) of the beneficiaries on monthly basis.
