Certificate Course in Sanskrit

Programme specific Outcome (PSO) for Certificate Course in Sanskrit

PSO1. The general objective of the one year certificate course in Sanskrit is to highlight the salient features of Indian cultural heritage preserved in Sanskrit texts to the Indian and foreign students. The course provides the syllabus with one paper.

Course Outcomes (CO) of the Course "Text & Grammar"

- CO1. The students will be exposed to Bhagavadgita's concepts of the divine and demoniac nature.
- CO2. The course intends to acquaint the students with ethical and moral values though some selected stories and fables from Panchatantra (Aparikshitakarkam).
- CO3. The basic rules of Grammar viz. Sandhi, shabdarup, kriyarup etc. will enable the students to construct and to understand the basics of Sanskrit language.

Diploma Course in Sanskrit

Programme specific Outcome (PSO) for Diploma Course in Sanskrit

PSO1. The general objective of the two years Diploma course in Sanskrit is to highlight the salient features of Indian cultural heritage preserved in Sanskrit texts to the Indian and foreign students. The course provides the syllabus with two papers.

Course Outcomes (CO) of the Course "Paper – I: History of Sanskrit Literature"

CO1. In the first paper of the syllabus, the history of Sanskrit literature, students would be acquainted with the knowledge of Vedic and classical Sanskrit literature.

Course Outcomes (CO) of the Course "Paper II - Grammar"

- CO1. In the second paper, the general rules of Sandhi, Samasa, Karaka, Kriyarupa, Shabdarup have been prescribed.
- CO2. By the knowledge of Grammar, the students will be able to understand Sanskrit language and Sanskrit texts properly

M.A. Sanskrit Course

Programme specific Outcome (PSO) for M.A. in Sanskrit

PSO1. The department of Sanskrit, with its post graduate program, intends to preserve, further and disseminate the various aspects and forms of ancient Indian knowledge traditions in modern perspectives and aspirations. CO1. To equip the student with the knowhow of highest aspects of Sanskrit literary composition representing the poetry & Dramaturgical piece of literature.

Course Outcomes (CO) of the Course "Paper_104: Outline of Culture & Civilization in Sanskrit Literature"

CO1. To provide the knowledge of the characteristics and development of various expressions of ancient Indian culture and civilization in vast body of Sanskrit Literature.

Course Outcomes (CO) of the Course "Paper_201: Darshana: Nyaya & Vedanta"

CO1. This course aims to enable the students to understand the basics of Indian logic and metaphysics according to Nyaya and Vedanta, Two prominent systems of Indian philosophy.

Course Outcomes (CO) of the Course "Paper_202: Vyakarana Laghusiddhantakaumudi"

CO1. This course introduces the students to the initial derivational process of the Sanskrit Morphology base on the Laghusiddhant Kaumudi.

Course Outcomes (CO) of the Course "Paper_203: Sahitya: Meghdoota & Uttararamacharita"

CO1. The textual study of two magnum opus of Sanskrit Literature is aimed to cultivate literary test and awareness in students towards ancient Indian literature.

Course Outcomes (CO) of the Course "Paper_204: Outline of Culture & Civilization in Sanskrit literature"

CO1. To provide the knowledge of the origin and development of various expressions of ancient Indian culture and civilization in vast Sanskrit Literature.

Course Outcomes (CO) of the Course "Paper_301: Linguistic Analysis of Sanskrit, Essay & Translation"

CO1. This paper introduces the students to the basic concept of the general linguistics and develops linguistics skills focused on the Sanskrit phonology, morphology, syntax and semantics. It also enables the students to learn the essay writing in Sanskrit and translation skill from other languages to Sanskrit.

Course Outcomes (CO) of the Course "Paper_302: Kadambari and Vasavdatta"

CO1. Kadambari & Vasavdatta represent the higher points of Sanskrit prose writing.

Course Outcomes (CO) of the Course "Paper_A303: Rigveda"

CO1. The course proved in depths study of the Rigvedic Hymns depicting several Deities thus expressing the ancient Indians religious believes system.

Course Outcomes (CO) of the Course "Paper_A304: Nirukta & Bharadvaja Shrautasutra"

CO1. The course through light on the various form of sacrificial & ritualstics aspect of Aryans life. The course also aims at understanding the deeper meaning of Vedic. Words through the Science of etymology propound by Yask.

Course Outcomes (CO) of the Course "Paper_B303: Yogasutra & Gaunapadakarika"

CO1. The paper gives an indepth study of the Yoga and Vedant philosophy with the textual study of Yogasutra and Gaudapadakarika respectively.

CO1. The course provides the further knowledge of the fundamental elements of the Indian literary criticism through and in-depth study of the magnum opus of Mammata, the ever celebrated text of Kavyaprakash.

Course Outcomes (CO) of the Course "Paper_D303: Siddhantakaumudi (Tinanta)"

CO1. This course enables the students to learn and acquire the advance knowledge of derivational process of the Sanskrit Verbal Morphology based on the Siddhant Kaumudi.

Course Outcomes (CO) of the Course "Paper_D304: Ashtadhayayi (Kashikavritti) & Siddhantakaumudi (Samasa)"

CO1. This course introduces the students to the basic principles of the structure of the Paninain Ashtadhayi. It also deals with the derivational process of the Sanskrit compounds base on the Siddhant Kaumudi.

CO1. To provide the knowledge the science of rituals and political institutions.
