### **AGREEMENT**

on an international cooperation between the

Julius Maximilian University of Würzburg
Faculty of Human Sciences
Institute for Education

and the

University of Delhi
Department of Adult Continuing Education & Extension

As part of a constant endeavour to promote mutual understanding and international scientific research, an agreement is hereby entered into on cooperation between designated departments of the Julius Maximilian University of Würzburg, represented by its President, Professor Dr. Dr. h. c. Alfred Forchel and the University of Delhi, represented by the Registrar, Professor Tarun Kumar Das.

### Article 1

Desiring to establish collaborative relations between the two institutions to promote friendship and to co-operate in a mutually beneficial association, the Department of Adult and Continuing Education of the University of Würzburg and Department of Adult Continuing Education & Extension of the University of Delhi agree to cooperate in the following fields:

- Exchange of academic faculty, administrative staff, visiting scholars, researchers, teaching staff, students and other staff mutually agreed upon
- Exchange of information and academic materials that are of mutual interest
- Establishment and organisation of coordinated classes,
- Conducting joint research projects,
- Organisation of international colloquia,
- Regular exchange of documentary publications and teaching materials.
- Briefing/orientation services by each institution for visitors from the other institution when possible and determined in advance
- Other forms of co-operation, which the two institutions may jointly arrange.

The two institutions shall decide through consultation the specific areas and details of co-operation within the framework of this agreement, and shall consult from time to time at the request of either institution for the purpose of reviewing the operation of this agreement. The two institutions shall encourage co-operation in any discipline, which is studied in both institutions. Details of any such activities will be subject to a separate agreement that will be mutually entered into and will be attached to this Memorandum of Understanding as an annexure.

### Article 2

A project may only be taken up once its funding has been secured. No financial obligations result from this agreement for either of the two parties unless mutual consent has been given.

The financial arrangements involved in the implementation of this agreement shall be settled through consultation between the two institutions in respect of each program of co-operation.

### Article 3

The number of students and academics who may participate in the exchange, the financial conditions for accommodating students and academics and all questions connected with this will be agreed upon separately in each individual case. Both Universities declare their willingness to give their guests from the partner university every possible support during their stay. The exchange will take place after a written invitation has been sent setting down all the details of each stay.

### Article 4

The agreement will come into effect from the date of most recent signature and is entered into for a period of 5 years with an option to renew for another five years. It may be modified or extended with the consent of both parties. Either party may terminate the cooperation provided that notice is given at least six months in advance. The institutions shall confer concerning the renewal of this Memorandum of Understanding six months prior to the date of expiration.

Any projects, training, or exchanges that may have commenced at either institution before the date of termination may be completed by special agreement between the two institutions. For condition not covered by this agreement, or for problems that arise during the course of this agreement, both parties undertake to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.

### Article 6

This agreement may be amended and supplemented by agreement between the two institutions. Amendments and or supplements will be appended as an annexure.

The University of Würzburg and the University of Delhi shall execute this agreement to the best of their knowledge and ability.

### Visitor's Tenancy Agreement (Gast-Mietvertrag)

(for the Visitors' Residence of the Julius-Maximilians-Universität Würzburg)

between the **Julius-Maximilians-Universität Würzburg** as a statuary body and

### § 1 Rented Accommodation

This agreement applies to the letting of a

one-roomed furnished apartment in the visitors' residence of the Julius-Maximilians Universität, including the furnishings and fittings as listed in the inventory, as temporary accommodation exclusively for the personal use of the tenant.

### § 2 Term of Rental

(1) The agreed term of rental begins on 31.01.2016 and ends on 14.02.2016.

The term of rental is limited as the lessor intends to let the apartment on expiry of the tenancy agreement to another tenant in service with the University in the field of research and teaching. An earlier cancellation of the tenancy agreement is in principle only possible if an adequate replacement can be found.

(2) German Federal Regulation § 545 BGB expressly does not apply to this lease. When the term of rental comes to an end, if an extension or renewal of the let is desired, a new tenancy agreement must be drawn up and signed.

### § 3 Rent

- (1) The rent is currently **Euro 180,00**per month altogether (each including electricity, gas etc.).
- (2) The rent is to be paid in full and in advance no later than the third workday of the month. It should be paid in cash or by bank transfer into the bank account of the Universität Würzburg, Acc. No. 420 189 86, with the Sparkasse Mainfranken Würzburg, Branch No. 790 500 00 (IBAN: DE81 7905 0000 0042 0189 86, SWIFT-BIC: BYLADEM1SWU). Alternatively, payment can be made personally in cash at the Accounts Office of the University (Zahlstelle der Universität, Zwinger 32, D-97070 Würzburg), opening times: Monday to Friday 8 a.m. till 12 noon.
- (3) For the rent to be paid punctually, it is not the date of the bank transfer but the date on which payment is credited to the University's account which counts.

(4) The University reserves the right to charge a € 5,00 administration fee for every reminder sent

### § 4 Deposit

- (1) On taking up occupancy, the tenant must produce evidence that a deposit equivalent to Euro 180,00 has been paid, either in cash or by bank transfer to the bank account of the University (see §3 (2)) or personally at the University Accounts Office (see §3 (2)).
- (2) The deposit will be used by the University to cover any claims it may have against the tenant which are still outstanding at the end of the lease. During the term of rental, the tenant does not have the right to demand that the deposit be used to meet any claim that the University may have against the tenant.

### § 5 Liability of the University

- (1) The University accepts no liability for any alterations, breakdowns or cuts in the supply of electricity, gas, water, fuel etc. provided by the public utility services; § 536 BGB is nonetheless unaffected.
- (2) The University as lessor will not be liable for any damage to the tenant's property caused by fire, smoke, soot, snow, mud, water or damp unless this is due to wilful damage or gross negligence on the part of the University.
- (3) The University cannot be held liable for any deficiencies in the rented property which were already present at the time of signing the agreement or which cannot be attributed to the University. Federal Regulation § 536a Clause 1 BGB is thus excluded.
- (4) The liability of the University is limited, insofar as this is legally permissible, in any other cases, to situations where wilful damage or gross negligence is involved.

### § 6 Start of Occupancy

- (1) The apartment shall be available for occupancy as from 3 p.m. on the first workday of the term of rental.
- (2) On moving in the tenant must sign the record of delivery of possession, by which he/she certifies that the apartment is in a proper

condition and the contents and fittings correspond with those listed in the inventory.

§ 7 Use and Care of the Property

- (1) The tenant shall take care not to disturb other tenants living in the building and respect their privacy and property in the interest of a pleasant relationship based on mutual consideration and shall observe the relevant house rules.
- (2) The tenant shall undertake to treat the apartment and its furnishings, fittings and effects, as well as the communal facilities, with all reasonable and proper care. The tenant must arrange for the apartment to be kept clean and, as far as technically possible, for the premises to be kept sufficiently aired and heated. Should the apartment give the tenant any cause for complaint, this must be reported to the University without delay.
- (3) The tenant is not permitted to sub-let the property or take in lodgers without the express permission of the University. The keeping of pets is not allowed.
- (4) The tenant is also liable for any damage caused by his/her guests.

### § 8 Right of Access

The tenant shall ensure that, even in the case of his/her absence, entry to the property is allowed to persons acting on the authority of the University for the purposes of inspection or to carry out any necessary repairs or maintenance.

### § 9 Repairs and Structural Alterations

- (1) The University reserves the right to carry out repairs, structural alterations or installation of fittings which are necessary or advisable for the upkeep of the property or apartment or for the removal of a safety risk or for the repair of damage, even without the agreement of the tenant. It reserves the same right in the case of measures undertaken to improve the rented property or other parts of the building or to reduce heating costs.
- (2) No structural alterations or building-in of equipment or fittings by the tenant are allowed.

### § 10 Notice of Termination of the Let

The University can terminate the agreement without notice if a continuation of the tenancy is

Würzburg,\_\_\_\_ Place and date unacceptable on serious grounds, especially a breach of contract, non-observance of the house rules or a breach of the peace on the premises.

### § 11 End of the Term of Tenancy

- (1) On expiry of the tenancy agreement, the tenant shall vacate the rooms by 10 a.m. on the last weekday before the final date of the period of rental. If the tenant does not fulfil his/her liability in this matter, the parties to the agreement agree that on expiry of the tenancy agreement, possession of the property shall pass directly to the University, and the University shall have the right to clear the apartment and install a new tenant, keeping the personal belongings of the tenant in store at his/her disposal, whereby the tenant waives the right to claim that the University has unlawfully taken possession of his/her property. The tenant expressly states herewith that after one year any possession and title that he/she has to the objects kept in store shall pass to the University.
- (2) At the end of the tenancy the property shall be inspected by the lessor. The apartment shall be left in a cleaned and tidy condition. If the degree of cleanliness of the rooms is not satisfactory, the cost of having the apartment cleaned shall be charged to the tenant. Up until this inspection the client is liable for any damage caused during the period of rental and for any items of the inventory that are missing. This liability extends up until such time as the keys handed over on entry are handed back to the lessor. In the case of the keys being lost, the University shall have the right to charge the tenant with all costs involved in changing or replacing the keys in question and all corresponding locks.

### § 12 Additional Points

- The tenant undertakes to give proof of his/her identity to the University, or a person acting on the authority of the University, on request by showing an identity card or passport.
- (2) Any written communication of legal significance on the part of the University addressed to the tenant shall be deemed to have been delivered on being posted in the tenant's letter-box in the visitors' residence.
- (3) Should any of the above points of agreement prove to be void, the legal validity of the rest of the agreement shall not be affected.
