It was also recommended that initially, allocation of Rs. 75.00 crore will be made by the UDF Committee with the condition that the same will be recouped if the funds are received from the UGC/ concerned Ministry.

45-6. Provision of lifts in building of Department of Commerce, University of Delhi.

The building committee considered the estimate amounting to Rs.41,70,551.00 for inviting tenders. For allocation of funds, this will be referred to UDF Committee.

45-7. Making bamboo hut for cooperative store at South Delhi Campus, University of Delhi.

The building committee considered the estimate amounting to Rs.30,24,705.00 for inviting tenders. For allocation of funds, this will be referred to UDF Committee.

Summary of Proposal

MA in African Studies

The Department of African Studies, University of Delhi is the first African studies department in India which was established in 1955 at the instance of the Government of India following a rapid increase in interest among Indians in Africa. The department started MA in African Studies in the 1950s to provide information and knowledge about Africa to the interested students and research scholars. However the MA program was discontinued though other programmes like Mphil/PhD, certificate and diploma courses continued.

In view of the renewed academic interest and orientation, the Department of African Studies, University of Delhi is proposing to re-start its MA programme with a revised course structure on "African Studies" from academic session 2021-22.

Programme Objectives

- To create experts in the field of International Relations and African Affairs
- To obtain a holistic perspective of the subject/area through multidisciplinary social science training
- To encourage a globally inclusive mode of scholarships in International Relations
- To promote studies of African ideas and experiences of International Relations
